Sub : Prequalification Tenders to shortlist Manufacturers for supply of Barbed wire, Chain Link Mesh & Plain Wire and to determine Rate Per Metric Tonne of Barbed Wire & Plain Wire and Rate per Sq. ft. of Chain Link Mesh for the Financial year 2010-11.



It is hereby notified, calling attention of the desirous Barbed wire, Chain Link Mesh & Plain Wire Manufacturers, that the Karnataka Forest Department intends to short list promising, prospective Manufacturers to supply Barbed wire, Chain Link Mesh & Plain Wire in manner to be specified, for the financial Year 2010-11.

The Tenders shall be submitted through e-Procurement Portal Only.

1. Tender forms may be downloaded from e-Procurement Portal website i.e. <https://www.eproc.karnataka.gov.in> and <https://www.karnatakaforest.gov.in> free of cost.
2. Rs. 550/- (Rs. Five hundred fifty) only to be paid online as application processing fee as per directions contained in the e-procurement portal.
3. Rs. 2,000/- (Rs. Two thousand) only to be paid online for issue of Tender Forms as directions contained in the e-procurement portal.
4. Rs. 25,000/- (Rs. Twentyfive thousand) only to be paid as EMD Charges online as directions contained in the e-procurement portal.
5. Time for receipt of tenders is up to 04.30 PM on 26-08-2010.
6. The Technical Bid will be opened in this Office on 30-08-2010 at 11.30 AM.
7. The approved firm and the rate will be announced in the website on 01-09-2010 at 04.30 PM.

8. If the above mentioned dates are declared as holiday for any reason, the subsequent working day shall be the tender submission or Tender opening day as the case may be.

9. **The rate should be quoted as below including applicable taxes.**

The successful "Rate Tenderer/s" shall be notified after due process and they will be intimated. After the intimation, the successful "Rate Tenderer/s" shall execute an agreement, with the PCCF within 15 days from the date of the intimation letter, on a stamp paper worth Rs.100/- to be purchased by the successful "Rate Tenderer/s". In the event of failure on the part of the successful "Rate Tenderer/s" to sign the agreement, the EMD shall be forfeited and such Tenderer/s" will be black listed and

declared not eligible to participate in the Karnataka Forest Departments' Barbed Wire, Chain Link Mesh & Plain Wire supply process for the next three years.

18. In the event of any of the above-indicated days happening to be declared as Holidays by the govt. the process shall automatically get shifted to the next working day.

19. Supply, Time schedule & Bank Guarantee :

The successful "Rate Tenderer/s" shall ensure that the supplies be strictly made within a time period of one month from the date of receiving the indent from the Deputy Conservator of Forests of any Forest Division. The Bank Guarantee of Rs.3,00,000/- (Rs. Three lakhs only) which will be in the form of irrevocable Bank Guarantee / Term deposit or in any other form acceptable by the PCCF and the same shall be pledged in the name of Principal Chief Conservator of Forests and its validity will be upto 3 months after 31st August, 2011, as a surety to adhere to the above mentioned supply time schedule. In the event of any short listed successful Rate Tenderer / Manufacturer failing to adhere to this time schedule, the Bank Guarantee concerned shall be forfeited and the manufacturer black listed and declared not eligible for participating in the Karnataka Forest Departments' Barbed Wire, Chain Link Mesh & Plain Wire supply process for the next three years.

On such inspection/investigations/enquiries if the indenting Deputy Conservator of Forests finds that any of the material supplied is of sub-standard quality he shall reserve the right to reject the whole or part of the consignment/material, within 15 days from the date of receiving the delivery of the supplies.

The Karnataka Forest Department shall not stand guarantee to any of the Financial Institutions/Banks, Raw Material supply agencies, Power Supply Authorities, Pollution Control Board, Municipalities etc. for any of their transactions / dealings. It is the responsibility of the successful Rate Tendered Manufacturing Industry to obtain clearances to the satisfaction of the concerned Organizations. Any disruption, arising in the supply of Barbed Wire, Chain Link Mesh & Plain Wire, on account of any of the above violations, the Manufacturing Industry cannot attribute it as a reason for not meeting the supply schedule.

The orders of supply indent from any of the Deputy Conservators of Forests shall not constitute as authorization by the Karnataka Forest Department to the Industry to enter into any financial or other commitments with any public or private institutions. All such transactions are purely at the sole risk of the concerned Industry only.

The Bank Guarantee of such of the successful Rate Tendered suppliers who have satisfactorily supplied the indented consignments shall be discharged by end of August-2011.

20. Bill payment :

The indenting Deputy Conservator of Forests will take action to settle the bills on receipt of the supplies. The time limit to settle the bills, arising due to supply of the indented material, shall be 90 days from the date of receipt of supplies subject to release of budget from the Government.

21. Appeals :

All appeals connected to the prequalification and Rate Tendering process shall lie with the PCCF. For any disputes, arising after the supplies or connected to supply indents appeals shall lie with the concerned jurisdictional Conservator of Forests of the Circle in which the said Forest Division lies, to which the supplies are made.
